# **BEST PRACTICES AND CAPACITY BUILDING**

## Houston NAC Conference - October 2023

Last year's NAC Conference in Houston, Texas, was a huge success. The Conference was well attended, with over 260 individuals participating. A representative from the City of Houston presented a proclamation recognizing the work of the NAC. The Conference featured two days of informational sessions, panel discussions, and substantive naturalization legal trainings. The Conference also offered an opportunity to volunteer at a naturalization workshop organized by the Houston NAC site, which had impressive participation from NAC partners. Many thanks to our Houston NAC partners for making this year's Conference a success.

## San Francisco NAC Convening - May 2023


In May 2023, the NAC hosted a Convening meeting of funders, national partners, and site leaders in San Francisco. It was the first in-person Convening since the pandemic started. It featured strategic planning discussions, best practice sharing on hybrid and virtual workshop models, and an all-day facilitation training to help site leaders enhance collaboration at their sites. National partners also had in-depth conversations with funders to discuss new funding strategies for the NAC.



## Supporting the Field: Trainings and Technical Assistance

NAC national organizations help partners expand and improve their naturalization programs to better serve lawful permanent residents. In 2023, the NAC offered the following support to local NAC programs across the country:

- National Partners Immigrant Legal Resurce Center (ILRC), Catholic Legal Immigration Network, INC. (CLINIC), National Partnership for New Americans (NPNA) provided 15 substantive legal and programmatic trainings and webinars to 2,800 plus NAC registrants
- ILRC provided over 120 naturalizationrelated Attorney of the Day Consultations to legal staff from partner organizations
- NALEO Educational Fund and AJSOCAL responded to over 8,600 calls from community members seeking information and resources on naturalization
- CLINIC worked with 25 NAC partners to provide consultations and review applications for the Department of Justice Recognition and Accreditation (DOJ R&A) program, resulting in the approval of 16 applications. Congratulations to NALEO Educational Fund for obtaining DOJ recognition in 2023!



In 2023, NAC partners advanced creative projects funded by the 11th round of NAC Innovation Grants. These projects included guiding people through the naturalization process with multilingual informational videos, using technology to improve efficiency in intake processes and at naturalization workshops, and building volunteer capacity through online trainings and resource libraries.

# **CIVIC ENGAGEMENT**

The NAC, in conjunction with UnidosUS, continues to support 20 NAC local partners in their Civic Engagement (CE) work. CE partners are using various methods to reach out to new citizens, including using texting platforms, phone banks, round tables, and community events, to educate newly naturalized and prospective citizens on



the importance of voting and ways to be civically engaged. They are also providing information and referrals to non-partisan partner organizations that can help new citizens register to vote. In NAC fiscal year 2023, over 1600 newly naturalized people who received assistance with their naturalization application from NAC partners were connected to voter registration and civic engagement opportunities.

# NATURALIZATION POLICY AND ADVOCACY

The NAC continues to combat naturalization barriers nationally through the Naturalization Working Group (NWG). Recently, the NWG made significant progress in reducing USCIS processing backlogs. Processing times to adjudicate naturalization cases have improved remarkably; the median processing times were cut in half – going from one year to just six months. Furthermore, the advocacy work of the NWG helped to secure an additional \$5 million for the Citizenship and Integration Grant Program in FY 2023.

### Red, White, and Blue Campaign

The National Immigration Forum continues to lead the NAC's Red, White, and Blue Campaign to inform LPRs traveling through airports about the benefits of citizenship and to connect them with naturalization resources, both through local NAC site engagement with airports and through a DHS partnership. In partnership with USCIS and CPB, brochures and informational videos are now available at 12 airports across the country. Members of the campaign met nearly monthly in 2023 to update each other, discuss strategy, and periodically met with CPB and USCIS to provide input and maximize impact.
